# Open basis recruitment for the Post of Livestock Development Instructor Class III of the Department of Animal Production and Health of the Uva Provincial Council Public Service - 2025

Calling of applications until 26<sup>th</sup> December 2025 from the applicants residing permanently within the Uva Province with the following qualifications to be recruited for the 28 vacant posts of Livestock Development Instructor of the Department of Animal Production and Health of the Uva Provincial Council Public Service.

## 1. General Recruitment Qualifications: -

- 1.1. Must be a citizen of Sri Lanka.
- 1.2. Must be of excellent character.
- 1.3. Person who is holding a religious order is not eligible to appear for this examination.
- 1.4. The applicant must be a resident of Uva Province with a continuous permanent residence of 03 years. (Extracts from the electoral rolls proving residence for the previous three years must be submitted at the time of interview. Applicants who are permanently residing in Uva Province as on the closing date for calling applications but cannot prove their previous permanent residence in Uva Province for 03 years must prove their spouse's continuous permanent residence in Uva Province for 03 years.)
- 1.5. Must be not less than 18 years of age and not more than 35 years of age as on the closing date for receipt of applications.

#### 2. Educational Qualifications: -

2.1. Passed in the G.C.E. (A/L) examination in three subjects in the Science / Mathematics / Technology stream with two of the following subjects relevant to the field. (Physics, Chemistry, Biology, Combined Mathematics, Biosystems Technology, Science for Technology and Agriculture)

And

Passed the G.C.E. (O/L) Examination in six (06) subjects in one sitting with a credit pass in Sinhala / Tamil / English Language, Science, Mathematics and one other subject.

## 3. Professional Qualifications: -

3.1. Have obtained the Diploma in Animal Husbandry in 2019/2020 or the Diploma in Agriculture in 2019/2020 from an institution recognized by the Tertiary and Vocational Education Commission.

OR

3.2. Have completed the National Vocational Qualification (NVQ) Level-06 qualification relevant to the field of employment

OR

3.3. Have obtained other technical qualifications recognized by the Tertiary and Vocational Education Commission as equivalent in all respects to the above technical qualifications after consulting and obtaining opinions from the Ministry of Higher Education and the abovementioned technical certificate issuing institutions.

## 4. Conditions of Service: -

4.1. This post is permanent. The pension scheme for the post shall be subject to the policy decisions to be taken by the Government in the future.

- 4.2. These applicants will be recruited to the post of Livestock Development Instructor Grade III of Department of Animal Production and Health of the Uva Provincial Public Service, and the salary scale Rs. 52,250 10 x 800 11 x 1190 10 x 1320 10 x 1350 100, 040/- of MN 3-2025 as per the Public Administration Circular No. 10/2025 will be paid for the post of Livestock Development Instructor Grade III of Department of Animal Production and Health of the Uva Provincial Public Service. Salaries will be paid up to 2027.01.01 as per Schedule III of the above circular.
- 4.3. Subjected to the general conditions of government appointments, the conditions laid down in the Recruitment Procedure that is approved by the Hon. Governor of Uva Province on 04.03.2020 for the Post of Livestock Development Instructor in the Department of Animal Production and Health of the Uva Provincial Council Public Service, and any amendments made or made hereafter to that procedure.

## 5. Recruitment Method: -

5.1. A written examination will be conducted by the Uva Provincial Public Service Commission for the candidates who have submitted applications with all the qualifications mentioned in this notification. Candidates who pass the written examination will be called for a qualification verification interview based on the priority of the marks obtained and recruitment will be made for the available vacancies after checking the qualifications.

## 6. Submission of Applications: -

- 6.1. Candidates appearing for these examinations should access the online application portal via the web link https://exams.psc.up.gov.lk/ and complete the online application for the examination on or before 11.59 PM on 26<sup>th</sup> December 2025 After completing the application and submitting it to the system (Submit), the soft copy of the application should be downloaded (Go to Application in the menu). A printed copy of the downloaded application should be obtained, the receipt of payment of the examination fee for the examination should also be affixed in the prescribed place, and the signature should be certified and should be sent to the "Secretary, Uva Provincial Council Public Service Commission, No. 14/4, Peelipothagama Road, Pinarayi Vijayan, Badulla" on or before 02<sup>nd</sup> January 2026 by registered post. The envelope should be captioned as "Open Recruitment for Grade III Livestock Development Instructor, Department of Animal Production and Health, Uva Province 2025" on the top left corner.
- 6.2. Applicants already serving in the Provincial Public Service or Central Government Public Service should submit their application through the Head of the Department.
- 6.3. Also, no changes will be allowed to any information entered through the online system. Therefore, it is important to check the information carefully before submitting it to the Uva Provincial Council Public Service Commission. All applications that are not properly completed and contain incomplete or incorrect information will be rejected without any notice. It will be useful for applicants to keep a photocopy of the application form and the receipt of payment.

Note: Online applications portal will be opened at 9.00 AM on 05<sup>th</sup> December 2025 and will be closed at 11.59 PM on 26<sup>th</sup> december 2025

## 6.4. Attestation of Applicant's Signature

6.4.1. Attestation of Signature of Applicants in Provincial Public Service / Central Government Public Service:

The applicant's signature should be attested on the application form and on the admission card of the examination. An applicant should have his signature attested by the Head of his institution or an officer authorized by him.

## 6.4.2. Attestation of signatures of applicants not in the public service: -

The applicant's signature on the application form should be attested by a Principal of a Government College / a Grama Niladhari of the Division / a Justice of the Peace / a Commissioner of Oaths / a Notary Public / a Superintending Authorized Officer of the Tri-Forces / an Officer holding a gazette post in the Police Service / an Officer of the Permanent Staff Grade holding a permanent post in the Government or Provincial Public Service.

## 7. Examination and Administration Fees: -

Examination fees and administrative expenses are Rs. 1250/-. This amount should be credited to the revenue head 20.03.02.13 of the Chief Secretary of Uva Province and the original copy of the receipt obtained in the name of the applicant should be sent by pasting in the prescribed place in the application form. It is mandatory to attach the original copy of the receipt to the application form and it is useful to keep a photocopy of the receipt for future use. Receipts, money orders or stamps obtained by paying money to institutions other than those obtained by paying money to a Divisional Secretariates of Uva Province will not be accepted and such applications will be rejected. The fee paid for the examination will not be refunded or transferred to another examination for any reason.

## 8. Examination Procedure and Syllabus of the Competitive Examination.

- 8.1. On the premise that only those who meet the qualifications mentioned in the recruitment notice have applied, the Uva Provincial Council Public Service Commission will issue examination admission cards to the applicants who have submitted their duly completed applications along with the relevant receipt of the prescribed examination fee on or before the last date of accepting of applications. Only if the number of formal applications, which meet all the qualifications mentioned in this notice, submitted by the last date of accepting of applications is more than the number of vacancies, such applicants will be placed for an open competitive examination without verification of certificates.
- 8.2. Admission cards will be sent by email at least two weeks before the examination, and the email address must be correctly mentioned when applying for the examination. If the admission card is not received one week before the exam date, a request should be made to the Uva Provincial Council Public Service Commission, stating a certified photocopy of the application form, along with the certified copy of the payment receipt and a WhatsApp number for sending the admit card. In addition, the examination admission card will also be available for downloading through link https://exams.psc.up.gov.lk/admission/. Accordingly, the admission card should be downloaded from the website, and after downloading the admission card from the website, carefully check whether if there are any amendments to be made and if so, the applicant should correctly indicate the manner in which the amendment should be made in the relevant column and affix his signature. Issuance of an admission card for the competitive examination will not be considered as an acknowledgement that the applicant has fulfilled the qualifications for this post.

- 8.3. The competitive examination is expected to be held in Badulla and Monaragala. The Uva Provincial Council Public Service Commission will decide on the town in which the examination should be held depending on the number of applicants.
- 8.4. Applicants should appear for the examination at the designated examination hall. Candidates are subjected to the rules and regulations laid down by the Uva Provincial Council Public Service Commission regarding the conduction of the examination and the release of results. Violation of the said rules and regulations shall be subjected to a punishment imposed by the Uva Provincial Council Public Service Commission.
- 8.5. On the day of the examination, the candidate must produce the National Identity Card, valid passport or valid driving license issued by the Department of Registration of Persons to the Officer in Charge of the Examination Center to prove the identity of the candidate. No other document other than these documents will be accepted.
- 8.6. Issuance of an admission card to appear for the competitive examination shall not be deemed to be an admission that the candidate has fulfilled the qualifications for the relevant post. If it is found during the interview that the candidate has not fulfilled the necessary qualifications, the candidate will be considered ineligible for appointment.
- 8.7. This competitive examination will be conducted in Sinhala, Tamil and English medium. A candidate must appear for the entire examination in one language medium. No change of language medium will be allowed after submission of applications.
- 8.8. The written examination will consist of 02 papers as follows. Each candidate must appear for both (02) papers.

## 9. Providing false information: -

If it is discovered that any candidate is not eligible to appear for this examination, his/her candidature may be cancelled before, during or after the examination. Even after recruitment, if it is discovered that any information furnished by a candidate is false or that he/she has purposely

provided false information or has deliberately suppressed accurate information, he/she may be dismissed from service.

- 10. The final decision on whether or not to make recruitments to these posts or to fill up part of the vacancies or the number of vacancies or any matter in this regard shall be the responsibility of the Uva Provincial Council Public Service Commission. Also, if there is any matter which is not provided in this notice, the Uva Provincial Council Public Service Commission will clarify/determine on the advice of the Hon. Governor of Uva Province.
- 11. If there is any discrepancy or inconsistency between the language medium of this announcement published in the Sinhala, Tamil and English medium, in such a case, action will be taken as per the Sinhala medium notice.
