



## **CLIMATE SMART IRRIGATED AGRICULTURE PROJECT (CSIAP)**

### **MINISTRY OF AGRICULTURE, LIVESTOCK, LANDS AND IRRIGATION**

#### **Recruitment of Project Staff**

The Climate Smart Irrigated Agriculture Project (CSIAP) is implemented by the Ministry of Agriculture, Livestock, Lands and Irrigation and funded by the World Bank. The objective of the Project is to improve the agriculture productivity via improving climate resilience agriculture in climatically vulnerable hotspot areas identified in six provinces namely North Western, North Central, Eastern, Northern, Uva/Southern. The estimated cost of the project is USD 125 Mn.

Applications are invited from the citizens of Sri Lanka for the following vacant positions in the project on contract basis. The applicants should possess the following qualification and experience given under each category.

#### **01. Finance Management Specialist (PS 3) – 01 Position at Project Management Unit**

##### **Qualification (1) or (2) or (3) below.**

- 1) A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an Associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field **with** at least 12 years of post-qualifying experience in the Managerial Level.
- 2) A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an Associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field **and** a Post Graduate Degree in the relevant field **with** 09 years of post-qualifying experience in the Managerial Level
- 3) A Class I officer of the Government All Island Services or a similar status in the relevant field **with** at least 4 years of experience in a Class I post.

**A brief job description for Financial Management Specialist:** Finance and accounts related matters considering CSIAP at the national level and building the financial and expenditure management system of CSIAP and will strictly follow all the procedures stipulated for World Bank funded projects, while observing the financial rules of the government of Sri Lanka.

**02. Internal Auditor (PS 4) – 01 position at Project Management Unit**

**Qualification (1) or (2) below.**

- 1) A successfully completed Bachelor's Degree in the Accountancy, Management, or Commerce field, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field **with** at least 08 years of post-qualifying experience at the related field.
- 2) An officer of the Government All Island Services Class III/II or above or similar status **with** at least 08 years of experience in Class III/II post.

**Additional requirement for the above post**

1. Experience in Government Auditing Practice and the establishment and maintenance of proper financial, auditing and controlling systems according to the GOSL procedure.
2. Working experience as an 'Auditor' in foreign-funded projects is preferable.
3. Computer Literacy
4. Proficiency in English

**03. Accountant (PS 4 – Category A) 03 positions at Eastern Province, North Western Province and Uva/ Southern Provinces**

**Qualification (1) or (2) below.**

- 1) A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an Associated membership/ a similar professional qualification obtained from the recognized professional institution in Accounting or Finance **with** at least 08 years post-qualifying experience in the relevant field.
- 2) An officer of the Government All Island Services Class III/II or above or similar status in the relevant field **with** at least 08 years of experience in Class III/II post

**A brief job description for Project Accountant:** The concern candidate should familiar with Government accounting system, assets management and stores management, the candidate with experience in World Bank and/ or foreign funded projects will be given preference.

**General Conditions:**

- Age Limit – Below Sixty-four (64) years on the closing date of application
- Employees are required to travel to project sites depending on the need.
- Working experience in the foreign funded projects in Sri Lanka is preferable
- Proficiency in English, Computer Literacy and familiarity with government rules and regulations.
- Salary for each position will be based on the Management Services Circular No. 01/2019 dated 05<sup>th</sup> March 2019.
- Short listed applicants based on qualifications and experience will be called for the interview.
