ELECTRICAL ENGINEER

Electrical Engineer is responsible to provide solutions to a variety of technical issues and assign, supervise the work of maintenance technical staff in the Maintenance Engineering Department and inspect their work for completeness.

The duties and responsibilities relevant to the position of Electrical Engineer among others are;

- Perform preventive service and maintenance work in MEP – related works, including HVAC, Generator, CCTV, Solar PV electrical, equipments, and other related systems in the head office building and branch network.
- Coordinate/inspect major renovations/refurbishment work on MEP and other related systems in the head office building, relevant outside departments and branch network.
- Manage appropriate third Party contractor support as needed for outsourced MEP equipment maintenance and repairs.
- Ensure that all maintenance jobs are completed in a timely, safe and responsible manner and be responsible for preparing work schedules, reports, coordination, execution of activities, work with maintenance team and perform other duties as assigned by the management.
- Authorize the payments related to the People's Bank head office building and branch network MEP repairs and maintenance work bills etc.
- Perform energy management system in the Branch network and head office building.
- Energy optimization and identify opportunities to improve energy efficiency and sustainability practices in the head office and branch network.
- Ensure that safety practices are followed and adherence to safety standards.
