**1. Job Description & Responsibilities**

1. Collection, Organizing, Analysis and dissemination of data relevant to Telecommunication industry, as required by the TRCSL.
2. Designing, developing and conducting surveys and statistical studies.
3. Designing, Creating and Maintaining databases and information repositories
4. Preparation of Statistical Reports & Publications
5. Assisting the management of TRCSL by provision of timely data and information required for decision-making.

**2. Educational Qualification and Experience**

A bachelor's degree with Statistics / Mathematics as a subject of the degree from a university recognized by the University Grant Commission

And

03 years of satisfactory service on permanent basis in Associate or Operational or Management Assistant Level in TRCSL

**3. Recruitment Procedure**

Recruitment will be done on the results of a written competitive examination, practical test, and structured interview.

Appointments will be made purely in the order of merit, obtained through the aggregated marks of the competitive examination practical test and the structured interview.

**Subjects of the written examination**

- A) Language Proficiency and Aptitude Test - 2 hours - 100 marks
- B) Subject knowledge relevant to the post - 2 hours -100 marks

### **3.1 Practical Test:**

This test is to assess the candidate's ability to apply his subject knowledge and skills in a practical scenario. A case / experience related to the subject area relevant to the post will be assigned and candidate's response within a pre-specified time will be assessed.

Candidates should secure at least 40% of the marks allocated for each subject and an aggregate of at least 50% of the total marks to pass the recruitment examination.
