**3. Qualifications Required for the Post of Electrical Engineer – Grade A-6**

- I. Must possess a degree in B.Sc. Electrical Engineering obtained from a U.G.C. recognized University.
- II. Must not be more than 32 years of age as of the closing date for applications.
- III. Must have passed a written examination.

**4. Qualifications Required for the Post of Mechanical Engineer – Grade A-6**

- I. Must possess a degree in B.Sc. Mechanical Engineering obtained from a U.G.C. recognized university
- II. Must not be more than 32 years of age as of the closing date for applications.
- III. Must have passed a written examination.

**5. Qualifications Required for the Post of Instrument Engineer – Grade A-6**

- I. Must possess a degree in B.Sc. Electronic/Electrical & Electronic Engineering obtained from a U.G.C. recognized university
- II. Must not be more than 32 years of age as of the closing date for applications.
- III. Must have passed a written examination.
