POST OF QA/QC INSPECTOR

Qualifications & Experience required.

- i. The candidate shall possess a Diploma in Mechanical Engineering field or an equivalent qualification from a recognized institution and shall have a minimum 04 years of experience in the inspection, fabrication, erection and testing of aboveground storage tanks in accordance with API 650 or works of a similar nature.

And

Qualification and certification in Non-Destructive Testing (NDT) with Level II in Radiographic Testing (RT) and at least Level I in Ultrasonic Testing (UT) and Penetrant Testing (PT), in accordance with ISO 9712 or an equivalent standard.

Or

- ii. Having obtained a Certificate of Proficiency (of at least at NVQ Level 4 or equivalent) in the field of Mechanical Engineering from a recognized institution, and having at least ten (10) years of working experience in the CPC/CPSTL Inspection Department, particularly in the inspection, fabrication, erection, and testing of aboveground storage tanks in accordance with ISO 650.

And

Qualification and certification in Non-Destructive Testing (NDT), with Level II in Radiographic Testing (RT) and at least Level I in Ultrasonic Testing (UT) and Penetrant Testing (PT), in accordance with ISO 9712 or an equivalent standard.

Scope of Work

- a) Review WPS, POR and WPQ as per ASME Section IX and API 650.
- b) Monitor welding, fit-up, alignment, and dimensional accuracy during tank construction.
- c) Ensure material traceability and proper documentation for MTCs, consumables, and weld records.
- d) Witness and record NDTs, hydro tests, vacuum box tests, PWHT, settlement surveys, and IFR installation.
- e) Verify calibration of inspection tools and compliance with project standards.
- f) Prepare inspection reports, weld maps, QA/QC records, and punch lists.
- g) Coordinate with contractors, clients, and inspectors to resolve quality issues.
- h) Perform other quality-related duties as assigned by the Project Oversight Lead.
