NDT/HNDE/NDES or equivalent qualification of a recognized University or Institute (relevant to the particular discipline) with four (4) years post qualifying experience in the relevant field including supervisory experience in a government or semi government sector or a reputed private Organization.

Scope of work

- Inspection duties include conducting destructive testing such as PT, UT, and MT, while also having knowledge of RT and monitoring its operations safely.
- Carry out visual inspections and ultrasonic thickness measurements on tanks and pipelines, prepare detailed inspection reports, and submit findings to the engineer for review.
- Quality assurance and control activities should be supervised according to standards, with accurate preparation of inspection documents.
- All activities require prior permits and approvals from the Health, Safety, Environmental & Quality Function, ensuring compliance with safety regulations.
- Execute assigned tasks under the guidance of engineers or senior officers, while overseeing and allocating work to subordinates to ensure quality and efficiency.
