Accordingly, applications are called in accordance with the specimen form annexed herewith in respect of appointment of officers to fill vacancies in the said posts and all eligible officers who have fulfilled all required qualifications as at the closing date of applications may apply for these posts. Should have completed an active service period of three (03) years in Grade I of the Sri Lanka Animal Production and Health Service and should have been engaged in active service as at the closing date of applications.

05. Out of the applications received, only the qualified candidates, who are in active service, will be called for a structured interview and the officers who have obtained highest marks will be appointed to the relevant posts based on their preference by the Public Service Commission. If the officer concerned is reluctant to accept the said appointment, the officer who has obtained the next highest marks will be appointed to the said post based on the order of marks and preference of the officer.
