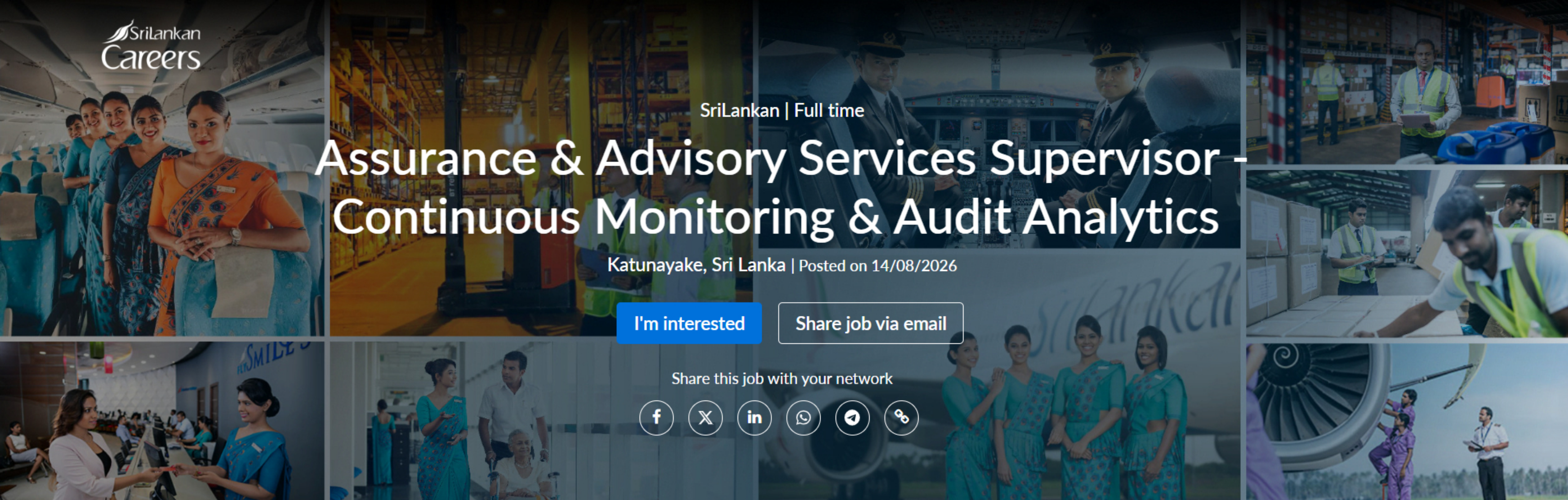

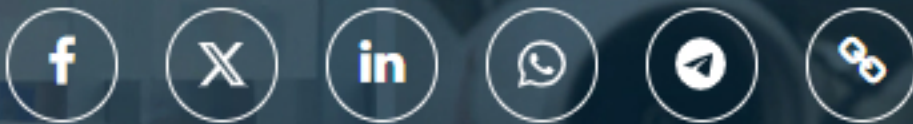

- Assist in conducting follow-up reviews to ensure that action owners have implemented the agreed recommendations appropriately.
