II. Having completed a five (05) years of satisfactory service in Grade II of Management Assistant Non-Technical (MA1) service category in the relevant field.

OR

II. Having completed a five (05) years of satisfactory service in Grade II of Management Assistant ' Non-Technical' (MA1) service Category in the relevant field.

07. Research and Development Assistant - 05 Posts

Qualifications and Experience

- **For external applicants**

(a) Having passed Six (06) subjects with credit passes four (04) subjects including,

i. Sinhala/ Tamil language

- ii. Mathematics

in the G.C.E (O/L) examination.

AND

(b) Having passed at least 03 subjects (except General Common Test) in Science stream or including Agriculture as a subject in the G.C.E (A/L) examination. (It is required to have passed 04 subjects under the old syllabus)

• **For internal applicants**

(a) Eligible employees mentioned below in (b), (c) and (e) in primary level unskilled, semi- skilled and skilled service categories can apply for this.

(b) Having passed Six (06) subjects with credit passes four (04) subjects including

- i. Sinhala/ Tamil language
ii. Mathematics

in the G.C.E (O/L) examination.

(c). Should hold permanent appointments in the service and should be made permanent in those appointments.

(d). Five (05) years of continuous satisfactory service period should have been completed in a permanent appointment prior to the due date;

Note: A period of training served prior to permanent appointment to a particular position or served as a condition for permanent appointment to a particular position shall not be considered towards the qualifying five-year period referred to in clause "e" above. Periods of temporary/casual service rendered prior to permanent appointment to a particular position shall not be considered towards the qualifying period of five years mentioned in item "e" above.

AND

(b) Having passed at least 03 subjects (except General Common Test) in the G.C.E (A/L) examination. (It is required to have passed 04 subjects under the old syllabus)

(c) Having followed a course of not less than 06 months in computer word processing/type writing recognized by the Tertiary and Vocational Education Commission or having obtained a similar level of skill.

- **For internal applicants**

(a) Eligible employees mentioned below in (b), (c), (d) and (e) in primary grade-non-technical, semi-technical and technical service categories can apply for this.

(b) Having passed Six (06) subjects with credit passes four (04) subjects including

(e). Five (05) years of continuous satisfactory service period should have been completed in a permanent appointment prior to the due date;

- ii. Should have the necessary physical and mental fitness to perform the tasks assigned to the position as well as to work in any part of the island.
- iii. Should be of excellent character.

Applications that do not fulfill these would be rejected. And the applicants who are already working in the government/corporations/boards should send their applications through the Heads of the institution.

* You should submit separate relevant applications for each position you are applying for (by using Annexure 01 and 02) and the positions applying for should be clearly mentioned in the application form.
