Context:

Working under the overall directives of the Resource Management Officer and the direct supervision of Heads of Human Resources, the incumbent will be responsible for:

Core Functions / Responsibilities:

- Provide transport for all IOM needs as required.
- Ensure adequate level of fuel and minimum running conditions of the vehicle.
- Day to day maintenance and cleaning of the vehicle, checking oil, water levels, battery, breaks, tyre pressure and attendance to routine repairs, in an effective and efficient manner.
- Delivering and collection of letters / mail / packages on behalf of IOM as requested.
- Ensures proper use of vehicle maintenance plans and assistance in preparing vehicle history report;
- Operate and maintain emergency communication equipment (VHF/UHF radios) in vehicle and ensure the accurate equipment, First Aid Kits and emergency supplies are in the vehicle at all times.
- Maintain vehicle log book by daily recording vehicle movements, fuel consumption and mileage done. Alerting supervisors of any repairs done to vehicle.
- Follow procedures as stipulated in the Transport Guidelines (i.e. Reporting of Accident).

Required Qualifications and Experience

Education

- High School Diploma with two (02) years of relevant professional driving experience.
- Valid driving licence is mandatory.

Experience & Skills

- Experience in driving both light & heavy vehicles will be an asset and thorough knowledge on local traffic regulations is required;
- Prior work experience within United Nations, international humanitarian organizations, non-government or government institutions/organization in a multi-cultural setting is an advantage.
- Experience in driving official vehicles and working with higher officials will be an asset.
