- ❖ The relevant applications should be sent by registered post only to the address below on or before 07th July 2025. The post applied for should be mentioned at the top left corner of the envelope containing the application. Incomplete, non-compliant or late applications will be rejected.
- ❖ Recruitment will be made through an open written competitive examination and/or a structured interview conducted by a panel appointed by the Appointing Authority as decided by the Board of Directors of the Institute. The decision of the Chairman/Board of Directors of the Sri Lanka Vocational Training Authority in recruitment shall be final.
- ❖ Candidates selected for the posts bearing numbers 7, 10, 12 and 13 above shall enter into an agreement with the Sri Lanka Vocational Training Authority to serve in the province/district assigned to them for a period determined by the Sri Lanka Vocational Training Authority based on the service requirement of this Authority. However, they shall be bound to serve in any service location assigned to them by the Sri Lanka Vocational Training Authority based on the requirements of this Authority.
