## POST OF TEMPORARY ASSISTANT LECTURER DEPARTMENT OF COMMERCIAL LAW

The University of Colombo will entertain applications from suitably qualified persons for the above posts up to  $21^{st}$  July 2025.

This is a Temporary position. Initially the appointment shall be for a period of 06 (six) months. The positions may be renewed for a maximum of another 18 months based on performance, and need during the period of the operation.

### 01. EDUCATIONAL QUALIFICATIONS

#### (A) <u>Temporary Lecturer:</u>

(1) A Degree in **Bachelor of Laws (LL.B**) with First or Second Class (Upper Division) Honours;

<u>OR</u>

- (2) A Degree in **Bachelor of Laws (LL.B)** with Second Class (Lower Division) Honours;
- <u>OR</u>
- (3) (a) A Degree in **Bachelor of Laws (LL.B**) without a class; and
  - (b) (i) A Doctoral Degree in Law or in the relevant field or
    - (ii) A Masters Degree in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/dissertation or
    - (iii) A full time Masters Degree in the relevant field of a minimum of 18 months duration with at least 60 credits\* of which not less than 15 credits\* of research by way of thesis/dissertation

[\*One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]

• Preference will be given to candidates who are proficient in teaching in both the selected medium and English.
